Installation Requirements

- CAT5/6 cable
- Phillips screwdriver
- Drywall or keyhole saw (to cut the hole in the ceiling tile)


TERMS OF USE: All Ethernet cabling runs must use CAT5 (or above). It is the customer's responsibility to follow local country regulations, including operation within legal frequency channels, output power, indoor cabling requirements, and Dynamic Frequency Selection (DFS) requirements.

System Requirements

- Linux, Mac OS X, or Microsoft Windows 7/8/10
- Java Runtime Environment 1.6 (1.8 or above recommended)
- Web Browser: Mozilla Firefox, Google Chrome, Microsoft Edge, or Microsoft Internet Explorer 10 (or above)
- UniFi Controller software v4.8.10 or higher (available at: downloads.ubnt.com/unifi)

Network Topology Requirements

- A DHCP-enabled network (for the AP to obtain an IP address as well as for the wireless clients after deployment)
- A management station running the UniFi Controller software, located either on-site and connected to the same Layer-2 network, or off-site in a cloud or NOC
- For public address system capability: A compatible Android™ or iOS device located on the same Layer-2 network as the UniFi Controller and UniFi APs




Sample Network Diagram

Hardware Overview

The UniFi AP AC EDU is comprised of the *Speaker Assembly* and *UniFi AP*.




Back of the Speaker Assembly



Clamp Bracket The four *Clamp Brackets* are used to secure the UniFi AP AC EDU to the ceiling tile.

Main This Gigabit Ethernet port is used to connect the power and should be connected to the LAN and DHCP server.

UniFi AP Ports



Secondary Reserved for future use.

Reset The *Reset* button serves two functions for the *UniFi AP*:

- **Restart** Press and release the *Reset* button quickly.
- **Restore to Factory Default Settings** Press and hold the *Reset* button for more than five seconds.

Alternatively, the *UniFi AP* may be reset remotely via a *Reset* button located on the bottom of the *Gigabit PoE* adapter.

Cable Feed Opening The *USB* and *Ethernet* cables feed through this opening.

USB The *USB* 2.0 port is used to support the *Speaker Assembly*.

Main This Gigabit Ethernet port is used to carry power and data.


LED



LED Color	Status
White	Factory default, waiting to be integrated.
Flashing White	Initializing.
Alternating White/Blue	Device is busy; do not touch or unplug it. This usually indicates that a process such as a firmware upgrade is taking place.
Blue	Indicates the device has been successfully integrated into a network and is working properly.
Quickly Flashing Blue	This is used to locate an AP. When you click Locate in the UniFi Controller software, the LED on the AP will flash. It will also display the location of the AP on the map.
Steady Blue with occasional flashing	Indicates the device is in an isolated state (all WLANs are brought down until an uplink is found).

Hardware Installation

1. Remove the ceiling tile.
2. Remove the backing from the *Mounting Template* and place it in the center of the ceiling tile.




3. Cut or drill a hole around the template.
4. Rotate the *UniFi AP* counterclockwise to release it from the *Speaker Assembly*.



5. Feed an Ethernet cable through the hole and connect it to the *Main* port of the *Speaker Assembly*.



6. If necessary, lift and rotate the *Clamp Brackets* so they remain elevated and tucked against the *Speaker Assembly*. Insert the *Speaker Assembly* into the hole.

7. We strongly recommend that you attach the *Safety Wire* (length: 430 mm) to a secure structural point using its clasp (inside diameter: 14 mm). Do NOT attach the *Safety Wire* to a T-bar in the ceiling grid.




Note: It is the installer's responsibility to verify that installation complies with local construction and safety codes.

Two examples are shown below.



8. Tighten the four screws attached to the *Clamp Brackets* to secure the *Speaker Assembly* to the ceiling tile.



9. To connect the cables:

- a. Feed the cables of the *Speaker Assembly* through its cable slot and the *Cable Feed Opening* of the *UniFi AP*.
- b. Connect the *Ethernet* cable to the *Main* port, and connect the *USB* cable to the *USB* port.



10. Insert the *UniFi AP* into the *Speaker Assembly*. Then align the notch on the top edge of the *UniFi AP* with the notch on the *Speaker Assembly*.



11. Ensure that the *UniFi AP* is firmly seated on the *Speaker Assembly*. Turn the *UniFi AP* clockwise until it locks into place.



12. Set the ceiling tile back into place.

Powering the UniFi AP

The UniFi AP AC EDU features auto-sensing 802.3at PoE+ support and can be powered by any of the following:

- Ubiquiti Networks UniFi Switch (recommended and sold separately)
- 802.3at PoE+ compliant switch
- Ubiquiti Networks Gigabit PoE Adapter* (48V, 0.5A)

* Included only in the single-pack of the UAP-AC-EDU.

Connecting to a PoE+ Switch

Connect the Ethernet cable from the UniFi AP AC EDU directly to a PoE port on the switch.

Connecting to a PoE Adapter

 **Note:** The *Gigabit PoE* adapter is included only in the single-pack of the UAP-AC-EDU.

1. Connect the Ethernet cable from the UniFi AP AC EDU to the **POE** port of the *Gigabit PoE* adapter.
2. Connect an Ethernet cable from your LAN to the **LAN** port of the *Gigabit PoE* adapter.
3. Connect the *Power Cord* to the adapter, and then plug the *Power Cord* to a power outlet.



Mounting the PoE Adapter (Optional)

1. Remove the *PoE Mounting Bracket* from the adapter, place the bracket at the desired location, and mark the two holes.
2. Pre-drill the holes if necessary, and secure the bracket using two fasteners (not included).
3. Align the slots of the adapter with the tabs of the *PoE Mounting Bracket*, and then slide the adapter down.



UniFi EasySetup App

You can use a mobile device to provision a UniFi AP for basic functionality without configuring a UniFi Controller.

Requirements

- An Ethernet connection from the UniFi AP AC EDU to the LAN with DHCP
- UniFi AP AC EDU firmware version 3.4.4.3231 or higher
- A compatible Android or iOS device

The following instructions describe the Android version of the app; however, the iOS version is similar.

1. Download the UniFi EasySetup app from the App Store (iOS) or Google Play™ (Android).




2. Launch the app, and use one of the following options:

- **Log In** Enter the Username and Password of your Ubiquiti Networks Single Sign-On (SSO) account. Tap **Log In**.
- **Register** To register for an SSO account, tap **Register**.
- **Continue** If you do not want to back up or restore configurations, you can skip the login and tap **Continue**.



- The app will search for new devices. Tap the UniFi AP AC EDU on the device list and go to step 5.



If a new device is not detected, you have two options:

- Scan QR Code** Tap **Scan QR Code** and go to step 4.
- Wi-Fi Settings** Tap **Wi-Fi Settings** and connect to your Wi-Fi network. Then the app will run a search again.



- Scan the QR code on the back of the UniFi AP AC EDU, or tap **You can enter your ID manually** to type the case-sensitive MAC address.



Note: For Android, the mobile device automatically connects to the helper SSID. For iOS, manually copy and paste the helper SSID and password.



5. Create a device login using the *Username* and *Password* fields. Select the appropriate *Country code* and tap **OK**.



6. On the *Config* screen, you can change *UBNT* (the default device name) to a descriptive name.


Configure the following settings for each radio:

- **Channel**
 - Select a channel number or keep the default, *Auto*.
 - Select the appropriate channel width.
- **TX Power** The default is *Auto*. Select **High**, **Medium**, or **Low**.
- **Name/SSID** Enter the name of the wireless network.
- **Enabled** Enable or disable wireless functionality.
- **Security** Select the security method you want to use.
- **Security Key** Enter the passphrase.

Tap **Apply Settings**.



7. Tap **Continue**.



8. Scroll down the *Config* screen to access the following:
- **Firmware Upgrade** Install the latest firmware on the UniFi AP AC EDU. (Not available if the latest firmware is already installed.)
 - **Forget This AP** Remove the UniFi AP AC EDU from management by the UniFi EasySetup app and reset it to factory default settings. All configurations and history associated with this UniFi AP AC EDU will be deleted.
 - **Restart** Power cycle the UniFi AP AC EDU.
 - **Locate** Flash the LED indicator on the UniFi AP AC EDU.




9. Return to the *UniFi AC* screen. Tap the overflow  icon in the upper-right corner, and then tap **Settings**. (The *Scan QR code* option adds another UniFi AC AP.)



10. The **Settings** screen offers the following options:

- **Secure Shell (SSH) Login Username** Change the username of the device login.
- **SSH Login Password** Change the password of the device login.
- **Country Code** Change the country selection.
- **Single Sign-On (SSO) Username** Change the username of the SSO account.
- **SSO Password** Change the password of the SSO account.
- **Automatic Configuration Backup** Enable or disable automatic backup of the current configuration.
- **Back Up Now** Back up the current configuration.
- **Restore** Restore the previously saved configuration.
- **Controller mode** Enable or disable use of the UniFi EasySetup App with a UniFi Controller.
- **Address** Enter the IP address of the UniFi Controller.
- **Port** Enter the port number of the UniFi Controller.

Tap **Apply Settings**.




The UniFi EasySetup app configures basic features accessed via a mobile device. Advanced features require the UniFi Controller software.

Controller Software Installation

Download and install the latest version of the UniFi Controller software at: downloads.ubnt.com/unifi

Launch the software and follow the on-screen instructions. Step-by-step instructions are available in the User Guide located on our website: documentation.ubnt.com/unifi

After you have installed the software and run the UniFi Installation Wizard, a login screen will appear for the UniFi Controller management interface. Enter the Username and Password that you created and click **Login**.



You can manage your wireless network and view network statistics using the UniFi Controller management interface.

UniFi EDU App

Ubiquiti Networks offers the UniFi EDU app so you can broadcast announcements with clarity from your mobile device.

Requirements

- UniFi Controller software v4.8.10 or higher
- A compatible Android or iOS device located on the same Layer-2 network as the UniFi Controller and UniFi APs

The following instructions describe the Android version of the app; however, the iOS version is similar.

1. Download the UniFi EDU app from the App Store (iOS) or Google Play (Android).




2. Launch the app.
3. Tap **Discover Controller**.



Note: Tap **Advanced** to manually enter the IP address instead. Then tap **Connect** and go to step 5.



4. Tap the UniFi Controller you want to use.



5. Enter the Username and Password, and then tap **Log In**.




6. Tap the site of your UniFi AP AC EDU devices.




7. After the app checks the status of the speakers, select the ones you want to use, and tap **Broadcast**.



Note: Use the slider control to adjust the volume for each speaker.



8. After the speakers initialize, begin the announcement. Tap **Stop Broadcasting** to end the announcement.



The speakers will automatically shut down when you stop broadcasting.
